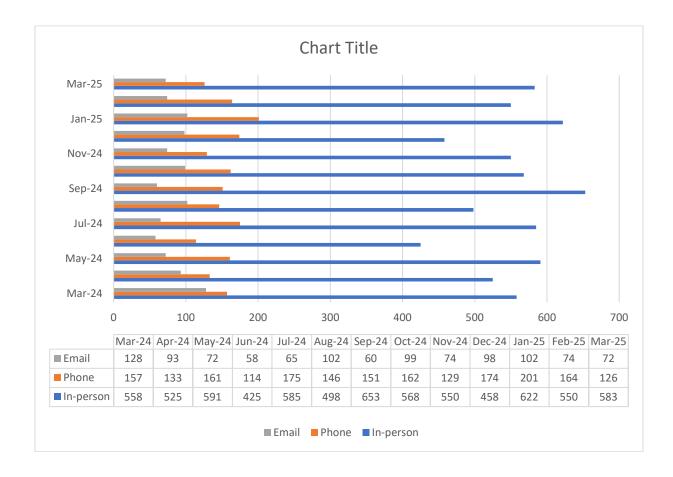

### FY 2025-2026 Budget Notes:

**Revenues:** \*We have an outstanding deposit which these numbers do not reflect.

Contributions: This amount is a hope.

Other Revenue: This amount will be pulled from our current fund balance. Without this our collections budget would be \$36,271. An application will be submitted for the CCCLL Mutual Aid grants in the hope that funding will offset the amount we will need to use from our fund balance. This additional money will allow us to thoughtfully decrease our collection over the next year.

### **Expenditures:**

CalPers: Our unfunded accrued liability (UAL) for the 25-26 Fiscal Year is \$64,074 up from \$58,199 last year. We have two separated employees and six retirees we are responsible for funding. Our UAL is not offset by current employee contributions because the Law Library, as an agency, does not have any employees. Our UAL is based on the 2023 report.

Subscriptions: As mentioned, this amount will require us to begin cutting our collection. Even if we are awarded money through the CCCLL Mutual Aid Grant we will need to start pairing down our collection.
